Wynthorpe Residents,

Please welcome new Board members Scott Bosley and Robert McClintock. These Board members are both long-time community residents interested in reducing homeowner delinquency and in improving and beautifying

the community. As new members of the Board, there are a few new policies and procedures for community business they would like to put into place.

On the last page of this newsletter is a **Volunteer Application** we are asking homeowners to fill out; this will aid us in building a stronger community by encouraging interaction between residents and the Board. As with any other volunteer position, there is no mandatory service obligation length. We just ask that residents consider donating a few hours a month to helping the community.

Safety Tips from the Department of Public Safety

- Never leave valuables inside your vehicle.
- Always close/lock your garage
- Do not leave garage door openers visible inside your vehicle.
- Do not leave ladders in visible places outside your home.
- Make sure all children (under 18) wear helmets if riding a bike (including those riding in toddler bike seats).
- Use of cell phones is strictly prohibited when driving.
- Use names in your cell phone address book instead of "Husband" or "Mom" in case it
- Be aware of surroundings when withdrawing cash from ATM or register.

One of the Board's primary responsibilities is to enforce the community Deed Restrictions. Please understand we only wish to remind homeowners of the importance of the proper upkeep of their homes. If you receive a Notice of Violation, please correct the issue as quickly as possible or communicate to the Board your wish to be aranted an extension or appeal. New Castle County has provided the community with a code

enforcement officer who will be responding to violations of the New Castle County Code of Ordinances as well.

- Pet waste on lot or common ground

Architectural Requests

The Board understands that along with warm weather comes home improvements. Please be aware that all homeowners must submit an Architectural Request (see right) prior to making any exterior changes to their home.

Common Exterior Alterations:

- Installing a new roof
- Replacing siding
- Replacing storm doors

- Installing a new garage
- Repainting of siding, shutters, doors, etc.
- Changes in landscaping (adding/removing trees, bushes, flower beds, etc.)

Making changes without prior approval puts the homeowner in violation of the Deed Restrictions and he/she will be subject to fines/penalties.

This being said, homeowners

are still be encouraged to make any necessary repairs or changes to their homes to keep the neighborhood an appealing place to live. Receiving approval from the Board for such changes generally takes no longer than 30 days.

- ⇒ Select "Wynthorpe Maintenance Corporation" from the drop down box on the right.

- ⇒ Review Article V of the Declaration to ensure your project is within the bounds of community guidelines.
- ⇒ Click on "Wynthorpe Architectural Request" to view and print the form.
- ⇒ Fill out the form in detail, including the dimensions, color, style, etc. of the proposed project. Attach plats, drawings, pictures, and any other necessary information.
- Mail, fax, or email the completed form to Taj Jones (see contact information on front page).
- If you do not receive a confirmation email or phone call, contact Aspen to check on the status of your request.
